NOTICE OF RACE**

RegattaPRO, a corporate member of the United States Sailing Association, organizes this series.

The RRS, the Prescriptions of US Sailing, Class Rules, the Sailing Instructions and this Notice of Race, shall govern this series. This series is designated Category A.

Race dates shall be November 4<sup>th</sup>, December 2<sup>ND</sup>, January 6<sup>th</sup> and February 3<sup>TRD</sup>. Two races will be run per day. The intended racing area will be the Treasure Island/Berkeley Circle area.

Warning Gun will be at 1130 hrs each day.

Courses will be windward/leeward courses set up using inflatable marks.

The low point scoring system RRS A4 shall be used. A minimum of one race shall be run to constitute a series. If four races are completed, there will be one throw-out. If seven or more races are completed, there will be two throw-outs. This series shall be scored as a series longer than a regatta.

Entry is open to the following classes with an entry of five or more boats:

Etchells	Moore 24
