Notice of Race

1.0 The Organizing Authority is the Treasure Island Sailing Center (TISC).

2.0 RULES

- 2.1 The regatta will be governed by the Racing Rules of Sailing (RRS) for 2005-2008.
- 2.2 RS 40.1 will be changed as follows: All competitors are required to wear life-jackets or other adequate personal buoyancy while on the water except for short times to adjust or change clothing. The "Y" will not be displayed.
- 2.3 Competitors are required to carry a bowline of at least 15 feet attached to a towing point while racing.

3.0 ELIGIBILITY AND ENTRY

- 3.1 Vanguard 15 boats conforming to the Vanguard 15 Class association class rules may be entered by completing the entry form and returning it with fee prior to the first start of the regatta to the Regatta Chair
- 3.2 All sailors MUST have a current TISC Medical & Liability Form on file BEFORE racing.

4.0 FEES

- 4.1 Clinic fee is \$15, payable in cash or check made out to TISC.
- 4.2 Regatta entry fee is \$25, payable in cash or check made out to TISC.

5.0 SCHEDULE

- 5.1 A clinic will be held in conjunction with TISC Opening Day on April 26, 2008.
- 5.2 Racing will be held on April 27, 2008.
- 5.3 Pre-registration is encouraged on the Vanguard 15 website (www.vanguard15.org).
- 5.4 Registration will be held until 1030 in TISC Club House.
- 5.5 Sailor's Meeting will be held at 1030 in front of TISC Club House.
- 5.6 First Warning will be at 1130.
- 5.7 A minimum of 4 races shall constitute a Regatta.
- 5.8 No race will be started after 1700 on Sunday.
- 5.9 Award Ceremony will follow the conclusion of racing on Sunday.

6.0 SAILING INSTRUCTIONS and NOTICES TO COMPETITORS

- 6.1 The Sailing Instructions will be available at registration and during the Sailor's Meeting.
- 6.2 All changes to the Sailing Instructions AND/OR Notices to Competitors will be published on the notice board located across from the Harbormaster Shack.

7.0 RACING AREA & COURSES

- 7.1 The intended racing area will be the San Francisco Bay east of Clipper Cove utilizing temporary inflatable marks.
- 7.2 Triangle or windward-leeward courses will be used. Gates and an offset mark may be used.
- 7.3 The 3 minute Sound-Signal Starting System (Appendix Q) will be used without visual signals.

8.0 SCORING & AWARDS

- 8.1 The Low Point Scoring System in Appendix A of the racing rules will be used.
- 8.2 Rule A4.2 will apply for daily award calculation. Rule A9 will apply for overall award calculation.
- 8.3 Awards will be given for first-third place.
